

### **Officer Reports:**

<u>First Vice President Ken Rowland</u> reported that Grievance U0007-18 (Management allowing hostile work environment) was filed and then settled in Step 3 to the Union's satisfaction.

Second Vice President David Reagan reported no new Step 3 Grievance Filed. Working U0001-18 for failing to equalize overtime in Dept.447 T/A materials. We have signed off step 2 and are continuing to monitor the issue. Joe Wessell and Mike Alice worked Step 1 with help from Larry Avery, step 2 worked by Bill Louis, Dave Reagan and Joe Wessell. (King's Highway)

Working U0002-18 for failing to follow Memorandum of Agreement #30 un just testing of a Union member per Education and Training 1B of said Agreement. We have step 1 signed off. Waiting for paper work to be released by yard hospital. Bill Stamp and Jeff Carver (Tower C).

Worked step 1 for a member suspended pending for Rules and Regulations. Violation of safety rules. Insubordination to a supervisor. Unfortunately, after a week of investigation by the company and a  $2^{nd}$  meeting with the Union and Company, the company has made a decision to terminate our member. Further meetings with the company we were able to get the company to agree to let the member retire in lieu of being fired. This issue happened in the Shipyard and was worked by Dave Regan and Jack Bond. (Second Shift).

Had two new cases of Security Violation Issues. (King's Highway).

Recording Secretary Martha Fletcher no new step 3 Grievances. Grievance U-0008-18, Failure to equalize overtime for D461 Test Writers was settled at step 2 in agreement to use baseline hours and discuss with management monthly. Thank you to Joe Husereau, Jim Newman, Jason Price and Mike Garduno for their hard work gathering all Test Writers hours in the different departments and meeting with management to work together moving forward.

### **Standing Committee Reports:**

**Joint Technology Committee First Vice President Ken Rowland** reported the JTC is meeting with company representatives to determine processes, roles and responsibilities for various tasks to be accomplished after product release. We will be getting a presentation on augmented reality and its implications to our design and procurement processes, if any.

Joint Apprenticeship Committee First Vice President Ken Rowland reported that Apprentice classes are ongoing for the first and second cohorts (class years). Tutoring and mentoring are available to any apprentice who may be struggling with a class, or who just would like some extra help with any issues. MDA Apprentice representatives are Velma Williams (867-4468) and Joe Marmaud (433-4584).

Joe Marmaud has accepted the position of SHIP (Summer High School Internship Program) coordinator for the MDA. We are currently seeking mentor volunteers for the 12 interns (D459 (4), D456 (3), D452 (3), D453 (2). There is also a possibility that an intern will be assigned to D447. Any mentor or backup will receive training at the union hall and will accompany the students on the Labor History day.

Design Pipeline classes have resumed; the next class is due to graduate 3-26-18. Approximately 30 graduates have been hired or offered MDA jobs as a result of this program, developed jointly by the company and union.

The south end stair cases were approved for Groton Building 184 (Cloud 9). Materials have been ordered, but yet to have a delivery date. EB personnel will be doing most of the work most likely over the course of a couple of weekends after the materials are in.

<u>Community Services Committee Chair Joe Wessell</u> reported planning for the 2018 Campaign is under way. We are working with the EBECSA Committee on the Campaign Slogan, Logo as well as the giveaways. We are working with the United Way Allocations process, reviewing the programs we help fund thanks to everyone who helped make 2017 another successful year.

Every year we end up getting asked why someone wasn't invited- and often it's because their service was simply not reported.

#### **Benefits Committee Ed Nevins** reported:

Accident & Sickness (A&S) Benefits & Family Medical Leave:

When filling a claim with Sedgwick, you will notice that the Family Medical Leave and A&S phone numbers are the same, both being 1-800-416-1808.

Do not be alarmed, you will be prompted with options for an Accident & Sickness Claim or Family Medical Leave Claim. So, please understand what option you are looking for.

A & S, provides employees up to 26 weeks of paid leave if you are unable to work due to illness or non-work-related injury you must report your absence to Sedgwick CMS immediately (Notify your supervisor and call Sedgwick at 1-800-416-1808. Sedgwick will ask a few general type questions, name, address, SS number, about illness, supervisor phone, physicians name/address, etc.). Sedgwick administrates / manages short term disability claims on behalf of General Dynamics.

FMLA, provides eligible employees up to 16 weeks of unpaid leave from work for certain family, health, related reasons, such as birth of child or to tend to close relative's serious health condition. The law specifies (1) work requirements employee must meet to qualify, (2) employee notice requirements and (3) circumstances under which an employer can require an employee to provide certification from health care provider. (It also prohibits employers from taking certain retaliatory actions against employees who take leave).

# HSA Debit Cards even more secure with the addition of a Pin Number:

Fidelity is enhancing the security of your Fidelity HSA® debit card with a Pin Number. Call 844-201-8403 from your home phone to set up your (PIN)-a 4-digit code.

It's now required at many pharmacies & healthcare providers.

Select Option 1, followed by Option 4, to create your PIN. (If you have more than one card, establish pin numbers for those cards also). This enhancement will allow the HSA debit cards to process payment transactions as either a debit or credit.

When signing up, here's what you'll will need:

Debit card (number, expiration date, and security code)

Social Security number of cardholder

Date of birth of cardholder

Fidelity Health Savings Account number.

The card can only be used for qualified medical expenses and cannot be used at ATMs or to get cash back on purchases.

# <u>UnitedHealth care Adds Shingrix to Preventive Benefits Beginning April 1</u>

In January 2018, the Advisory Committee on Immunization Practices (ACIP) recommendation on Shingrix was adopted by the Centers for Disease Control and Prevention (CDC). Shingrix is the preferred vaccine for preventing shingles and related complications. It's recommended for healthy adults aged 50 years and older to prevent shingles and related complications. It is also recommended for adults who previously received the Zostavax® shingles vaccine to prevent shingles and related complications. Shingrix is not recommended for individuals ages 49 and younger.

For non-grandfathered fully insured and self-funded clients that follow UnitedHealth care standard preventive services benefits, Shingrix will be included as a covered benefit beginning April 1, 2018.

The cost for Shingrix is approximately \$148 per injection. There may also be a separate administration fee. Shingrix is paid as preventive under the medical benefit, not the pharmacy benefit.

The President called up Debbie Basnight to run the nomination process for the convention. Twelve members were nominated for the 4 delegates and 2 alternate spots.

Election Committee Deb Basnight conducted nominations for the election to fill four (4) delegates and two (2) alternates for the Thirty-Seventh Constitutional Convention of the United Automobile, Aerospace and Agricultural Implement Workers of America, in Cobo Hall Convention Center, Detroit, Michigan. The Election will take place on Monday, March 26, 2018. If a run-off is required it will be Monday, April 2, 2018. Times and polling places are to be distributed in a separate memo.
