

January 10, 2019

2019 Annual Enrollment:

- Your Benefits selections are in-effect for the upcoming year. Make sure your selections and weekly contributions agree with those selections. If not, contact the GD service center at 1-888-432-3633.
- You should have reviewed your enrollment information, make sure you understand your selections, changes and or updated information for 2019.
- For changes to the plans deductibles, coinsurance, out pocket expenses, prescription drug costs and weekly premiums are addressed in the collective bargaining agreement (ABHP).
- Following enrollment our benefits committee worked to ensure members that signed up for the standard plan did so by election and not in error.

HSA Account:

• IRS max amount to contribute is \$3,500 (\$50 increase from 2018) individual, \$7,000 (\$100 increase from 2018) all others.

FSA Account:

- Our administrator is Wageworks.
- Rollover (Carryover) money for FSA is up to \$500.
- Wageworks offers a mobile app or you can visit through <u>www.wageworks.com</u>
- IRS maximum contribution for 2018 was \$2,650 and for 2019 will be \$2,700.

Sedgwick will ask a few general type questions, name, address, SS number, about illness, supervisor phone, physicians name/address, etc.). Sedgwick administrates / manages short term disability claims on behalf of General Dynamics.
