

Committee Reports:

We would like to recognize and thank the MDA members, their family members and our Union Leadership who showed up to volunteer along with MTC, Carpenters, salaried employees, many with their family members, and the United Way of Southeastern CT staff. This is truly a team effort here at Electric Boat.

In 2 hours with about 60 volunteers, we were able to contribute 48 pallets of food and other household items at a total of 28,812 lbs. Everything collected was taken to the Gemma E Moran United Way/Labor Food Center to be sorted and distributed to over 90 different distribution sites including food pantries, shelters, child care centers, community meal sites, programs for the elderly and the mobile food pantry-all at no cost to those in need.

Trustee Committee Chair James Newman: reported, the week of March13, 2022, Eric and I attended the Financial Officer's Conference in New Orleans. We were able to get some updated training as Trustees and learn from listening to challenges some of the other Regions and locals are having. One of the top issues was the balance of the strike fund which is the determination for when our dues goes back to 2 hours/month vs the 2-1/2 hours per month. They are projected to hit that milestone in October this year. We were greeted by our region 9A Director, Beverley Brakeman, UAW Secretary-Treasurer, Frank Stuglin and our UAW President, Ray Curry. Listening to the other union leadership from across the country (Presidents, Financial Officers, Trustees and other union representatives) makes us realize how fortunate we are to have the leadership in our office and the relationship and respect we have established with the company. Benefits Committee Member Tony Giordano: reported Connecticut Paid Leave and Sedgwick: This continues to be a challenge for our members. I would recommend that if you're having surgery, pregnant and giving birth, ill, or need to care of ill family members to give one of the committee members a call so we may walk you through the process. EB Communications: The latest information concerning COVID-19 can be accessed on Homeport for new audio messages and using the EB landing audio.

<u>Dependent Audit Verification, FSA Unsubstantiated Claims & Opening HSA Accounts to</u> receive seed & match: Last month we reported we would reach out to members affected making them aware of deadlines. They have all been notified by e-mail or phone.

Employee Assistance Program: The EB Family Wellness Center is now offering Employee Assistance Program counseling to all EB Employees. Solutions is no longer taking new clients but will see current clients through the end of June. If anyone does call Solutions, they will be referred to the Family Wellness Center. In addition, Optum EAP is still available as well and can be accessed by calling 866-743-6551. Eight free counseling sessions per person, per year, per issue are available for all EB employees and their household members.

EB Wellness: The EB Wellness team is visiting areas in Groton to offer wellness events during the remainder of March. See below for schedule and offerings. This was also offered in NL tower by tower.

Sedgwick COVID Short Form: The company let us know that due to decreasing COVID occurrences in the community and COVID claims with our disability vendor Sedgwick, the COVID attestation form (or COVID "short form") will no longer be available. Claims that are currently open/pending will still be allowed to use the attestation form because one has already been provided. However, normal protocols will apply to claims that are reported as of March 21, 2022

going forward. What does that mean to you: The form was used to help employees because getting in to see physicians during COVID-19 was difficult. The form allowed employees to fill out and submit and could be off work, not to exceed 14 days and would be paid. Your signature certified that you consulted with a physician. The company has gotten away from that form because doctors are seeing patients and the claims and reported cases have gone down. EB Pharmacy: The EB Pharmacy has expanded hours starting March 30, 2022 in NL cafeteria to include 6 pm-6:30 pm on Mondays and Thursdays. (The EB Pharmacy is able to send prescriptions right to your home with two day FedEx shipping). You can reach the EB pharmacy at 1-888-578-3457 and if you're sick and unable to pick up your Rx they can make arrangements to mail them to you.

EB Optical: The New London Optical Shop located inside the NL Fairwater store will be closing for the time being. The Groton Optical shop located by the shipyard main gate will remain open. S.H.I.P. Committee Chair Joe Marmaud: reported a kick-off meeting was held on Friday, March 18, 2022. This year for the management side, Human Resource Dept. will be running it in lieu of the Training Dept. Management has been notified to get the number of interns each discipline can accommodate and to determine where they will be working. Some of the SHIP interns are now fulltime employees in MDA-UAW which is the goal of the program.

Safety Committee Co-Chair Rob Gaudiano: reported, please be careful in the NL parking garage. There is a lot of construction going on and the spaces are very limited for vehicles to park on certain levels. Safety will keep you informed when we find out more about completion dates.

Old Business: MDA apparel is available. There are some new items available and we now have 2 logos to choose from. There are some items that have been discontinued. New Business: A motion was made to support the annual fund drive for the New London Police, Local 724 with a ½ page ad of \$395, (Mike Alice), seconded (Glen Pothier) and passed to accept.

A motion was made to support the ULA with a donation of \$500, Jim Newman, seconded, Mike Alice, and passed to accept.

A motion was made to support the registration cost of \$65 per member attending the UCAN training, (Glen Pothier), seconded (Eric Straub) and passed to accept. We have 3 members interested at this time.

A motion was made to support Region 9A Solidarity Fund with \$2500 to help Locals with travel expenses for those who can't afford it, (Steve Karavolis), seconded (Mike Alice) and passed to accept.

A motion was made to pay loss time for, up to 3 members and lunch for, 15 to 20 folks working the Workers Memorial clean-up at Washington Park, (Mark Ciliano), seconded (Steve Karavolis) and passed to accept.

For Good of the Union: WFH is here to stay, be accountable and responsible when working from home.

BIW just ratified their latest contract. Some highlights, 4-year contract, 3% GWI each year, 6% match increase for SSIP and a first time NCRC benefit for those without a pension, 4-10 hour day schedule increased to use 15 times during the year, minimum 4 hour work day, part time options and non-smoking incentives. Congratulations to BIW on a successful negotiation.

There was a discussion last month on going back to in person for June, for our meeting. That Monday in June is not available so we have decided to stay with Zoom, as approved a couple months back. We will be back in person for the September General Membership meeting.

The self-checkout machines in the New London cafeteria were brought up at the meeting. We should keep in mind that the cafeteria workers are union also and will be losing jobs if employees continue to utilize the "scab" machines. Please pass the word, utilize a person working to check you out, you may be saving someone's livelihood. This was at EB's request to put them in, not the Vendor's.

President William E Louis swore in the 2 newest councillors, Greg Main and Jacob Miller. Congratulations and thank you for stepping up and helping the members, much appreciated.

A suggestion was made to open up the Bereavement union benefit to retirees also. For that to happen, a By-Law change must be submitted and approved. We will be working on a proposal for that option to present at the next General Membership meeting.
