

First Vice President Ken Rowland reports no new step 3 grievances filed.

Recording Secretary Martha Fletcher reports no new step 3 grievances filed. A member has been terminated for 2nd offence dozing.

Financial Secretary William May reports no new step 3 grievances filed. U-0028-19 was settled at step 3 with a member receiving 9-hours bereavement pay.

Treasurer Robert Faraci reports no new step 3 grievances filed.

Standing Committee Reports

Joint Technology Committee First Vice President Ken Rowland reports a meeting originally scheduled for March 16th to discuss concerns about DpD creation and revision, along with some Piping processes was cancelled due to illness and COVID-19 absences. That meeting will be rescheduled for a later date and be held remotely.

Joint Apprentice Committee First Vice President Ken Rowland reports due to the Coronavirus concerns and impacts to classes taught by Three Rivers Community College, classes were suspended for Apprentices for a few weeks. Discussions between TRCC, the Apprenticeship office, and the MDA have resulted in a plan to continue classes via virtual learning platform(s). Students on first shift will be able to engage in interactive learning sessions conducted at the regular class times. Second shift students will be able to participate in those classes at the same time and have that time counted toward their work shift, or view recorded training sessions form the same day, at their discretion. Velma Williams is available on first shift, and Joe Marmaud on second shift, to help with any issues the apprentices might be facing. Thanks to Velma, Joe and the Apprenticeship office along with TRCC for working together to find solutions to the class interruption.

Scholarship Committee Recording Secretary Martha Fletcher reports the John F. Saffomilla and E Roy Colville Scholarship for 2020 are available through your grievance representatives and are on our website. Students in their senior year of High School pursuing higher education and whose parent, grandparent or legal guardian is a Local 571 member, in good standing, are eligible. Applications will be judged by independent Judging outside the Local. 8 students will be chosen to receive scholarships in the amount of \$2,500.00. April 24th is the deadline for submissions and must be submitted through the mail, can't be hand delivered. Thank you and please let us know of any questions.

Property Committee Financial Secretary William May reports that the committee received 3-quotes for the Union Hall bathroom repairs as follows: Tetlon Builders \$3,420.00 plus cost of new urinal verses reinstall old one. Advanced Improvements \$21,358.00, selection of contractor on hold due to COVID-19. Yankee Remodeler \$11,600.00.

Veteran's Committee Financial Secretary William May reports the Veteran's Committee is planning a bus trip to Washington, DC, September 11 thru September 13, 2020. The cost per family is approximately \$230.00 which includes bus transportation and 2 nights lodging 1 room, 2 double beds per family. 1 person must be an MDA member in good standing. The Union is covering the bus and 1-night lodging. The buses will leave the EB parking lot (lot TBD), Groton at 5:00 am, Friday, September 11th and return a time to be determined Sunday, September 13, 2020. Benefits Committee Chair Ed Nevins reports:

COVID-19:

The MDA Benefits committee continues to help members who have questions or concerns dealing with our benefit plans. Know where to find information and COVID-19 cases. Know the signs and symptoms of COVID-19 (Coughing, Shortness Breath, and Fever) you should stay home and contact your healthcare provider, seek appropriate medical care or if at work you can reach out to EB Wellness center. If you're looking for information, I recommend the CDC Centers for Disease Control and Prevention. The CDC provides information on protecting yourself, if you're an older adult, over age 65 concerns, Mask protection, Latest News on Scams, etc. Visit www.cdc.gov

EB Communications:

The latest information concerning COVID-19 can be accessed by Homeport for new audio messages and using the EB landing audio.

Union Communications:

President Bill Louis has been meeting with the company regularly and providing daily updates on the MDA UAW Local 571 face book page. I recommend your like the page and obtain your daily information concerning the virus, and any changes taking place effecting working conditions. Bill has been providing much needed information to the membership and getting that information to you instantly. During these times he has been doing a great job making sure you the member are kept up to date. Many of the members I know really appreciate those efforts which are not easy.

COVID-19 Household plan:

Create a household plan of action in case of illness or disruption due to COVID-19. Make sure your prescriptions refills are up to date. Individuals of higher risk should consult with your physician. Avoid travel, Gatherings and other potential exposure.

EB Pharmacy:

The EB Pharmacy has expanded its hours starting March 30, 2020 in NL cafeteria to include 6:00pm-6:30pm on Mondays and Thursdays. (The EB Pharmacy is able to send prescriptions

RI members can utilize the Quonset Point Pharmacy if that makes things easier. CT and RI share the same computer system. Scripts can be transferred to RI, the only ones that we are aware of that require a new Rx script is scheduled II control substances.

EB Wellness Center:

Virtual visits are available to employees and dependents (Over age 2), even if you have not visited the wellness center before. The term virtual covers wide range of services, you can get help assessing what's going on with you or your child and get recommended next steps next best steps, whether over the counter medications, prescriptions, follow up with primary care provider or even an immediate trip to the emergency room. The video visit is \$45.00, just like an in person visit, less than you would spend at other walk in clinics and far less than a trip to the emergency room. (Video visits on Allergies, Back Pain, Cold/Flu, Ear Aches, Fever; Follow up appointments, Headache, Medication refills, Nausea, Rashes & Bites, Sinus Infections, Sore throat). Log into MY Premise Health mobile app or sign up. Hours of operation Monday-Thursday 7:00am-6:00pm, Friday 6:00am-5:00pm & Saturday 8:00am-1:00pm. FollowMyHealth and MyChart:

If you are experiencing trouble logging into these sites to track medical information contact the Wellness center and tell them they are having an issue getting to the portal.

Short Term Disability (A&S):

If you are unable to work due to illness or non-work-related injury you must notify your supervisor and call Sedgwick at 1-800-416-1808 to file a claim. Sedgwick will ask a few

general type questions, name, address, SS number, about illness, Supervisor phone, physicians name/address, etc.). Sedgwick administrates / manages short term disability claims on behalf of General Dynamics.

HSA Accounts:

The EB benefits office recently notified the MDA benefits committee that we have members that selected the Enhanced ABHP benefit plan and have not opened an HSA account. We have reached out to those members as well as the company to help them receive their seed, match and tax-free money into account.

Dependent Verification:

If you receive a letter asking you to verify your dependents, you should take this seriously as it comes with a deadline. If members fail to provide the necessary documentation coverage will no longer exist following the deadline. If members still do not produce documents a Final notice reminder and outbound call is placed. (Remember when adding a dependent to your insurance policy you are required to provide documentation to confirm the eligibility of the dependent(s) you recently added to coverage in the General Dynamics Health Plan).

Process: You would receive a Letter from GD stating important Benefits Information Action Required). This must be filled out properly with all the important documents they require to prove eligibility. They tell you to log onto the www.verifyOS.com to review dependents and documents required to verify eligibility. HMS must receive all required documents and provides a date they must be returned by. IMPORTANT: HMS is GD's 3rd party dependent verification auditor. If you do not submit all required documents to confirm eligibility of your dependents, your ineligible dependents will be removed from all Health Plans (Medical, Dental and Vision). The benefits committee reached out to the 38 members providing reminders and recommendations to complete HMS verification process. **The deadline is April 9, 2020** recommend double check with them to make sure they received your information. (The process seems to be a simple one once you have in hand the documents required. One of our committee members was part of a previous Audit).

Workers Compensation Committee Chair Tim Carlson reported if someone has lost time due to a work-related injury, sometimes the EB's compensation department forget to ask if the injured person is an MDA member. You are entitled to SDIB (supplement disability insurance benefit) which will make you whole to 40 hours. MDA members accrue SDIB days every year per our contract. Members can call the Workers' Compensation Committee for information. Please report any work-related injuries to the yard hospital.

New Business:

The Union Hall received an estimate to deep clean the Hall including carpets, tile grout and office furniture along with disinfecting for a few examples. Only 1 business, out of 3, got back to the hall with an estimate of \$1202.23. An email vote was taken by the executive council, 35 to 2 and passed to accept.

I would like to thank everyone for all doing your part during this crisis. As we continue to work with the company, we do understand the frustration and unknowns that we all face with COVID-19. We are continuing to bring forward the options provided and welcome any questions you may have by calling 860-448-0552. Just to recap some of the things being provided today;

We have an un-paid shop order, 00002852, that can be utilized at any time and for as long as you need it. The company has also provided a paid shop order for up to 80 hours, 00002720, for members to utilize if needed (just keeping in mind, any of this used will have to be paid back by the end of 2020), MDA has had the option to work from home, never had this option in the past, A&S claims have been getting approved in the past week for those submitted in regards to the COVID-19 and support from your doctors, the 2 shifts, volunteers only, which has help much with social distances just to mention a few. Nobody will have any discipline due to lost time during this crisis. I understand some don't like any of these options and we will continue to work with the company and communicate anything new as we go forward. As of today, we have 9 positive results, I believe, including the EB President. Our priority should be our families and our health, so utilize what options are out there that better fits your circumstances and again, please contact the union office with any questions.
