

By Law Committee Treasurer Robert Faraci reported a By-Law change proposal was submitted to the committee. The proposed change has been tabled to the September 13, 2021 General Membership Meeting:

Proposes By-Law Change: changes in bold

Article XIV, Section 1 - Electing the Election Committee

- a. The Local Union Election Committee shall be nominated and elected at the regularly scheduled December membership meeting in the year prior to the year in which Executive Board terms expire.
- b. The Election Committee members shall serve for three year terms. The Election Committee shall consist of five (5) members.
- c. In the event a vacancy occurs within the Election Committee, the Local Union Election Committee will hold nominations and elections at the next general membership meeting to fill the vacancy.

The members of the Election Committee shall select their own chairman.

It shall be the responsibility of the Election Committee to conduct and supervise the nominations, election and appeals process of all local union elections.

The Election Committee will report to the membership on the arrangements for the conduct of the general election, such as date, time and place and any other matters

specified in the latest UAW Publication of the Guide for UAW Local Union Election Committees. The Election Committee reports shall be subject to the approval by the membership.

Building and Property Committee Financial Secretary Dave Evans reported the committee is accepting estimates to fix / replace the front door to the Union Hall.

The committee has received a price for landscaping and mulching areas around the parking lot at the hall. This cost is under \$1,500.00 and does not require approval per our By-Laws and will be completed soon.

Dependent Verification:

Periodically dependent verification is required for members who enroll new dependents, make changes or fall under a random audit. Members receiving letters are given deadlines to complete the necessary steps. Members not completing these steps are provided communication reminders.

Process: You would receive a Letter from GD stating important Benefits Information Action Required). This must be filled out properly with all the important documents they require to prove eligibility. They tell you to log onto the www.VerifyOS.com to review dependents and documents required to verify legibility. HMS must receive all required documents and provides a date they must be returned by. IMPORTANT: HMS is GD's 3rd party dependent verification auditor. If you do not submit all required documents to confirm eligibility of your dependents, your ineligible dependents will be removed from all Health Plans (Medical, Dental and Vision). For more information visit www.verifyOS.com or call GD Help Line at 1-877-321-0791, Monday thru Friday 8:00 am to 8:00 pm.

We ask that you complete these steps in order to maintain coverage of your dependents. <u>If you are having problems obtaining documents to support these actions you should notify HMS and one of our benefits committee members so we may help.</u>
