

Insurance and Benefits Committee Chair Ed Nevins reported: **2022 Annual Enrollment**:

Annual Enrollment ended Friday December 3, 2021 at 11:59pm:

- You should have double checked your selections, and printed your confirmation / selections.
- HSA Account: Per IRS maximum amounts you can contribute for an Employee only \$3,650 and for all other coverage levels \$7,300. If you are age 55 or older you may contribute an additional \$1,000. This can be adjusted throughout the year.
- In order to get the Seed / Match you must have selected the Enhanced option. The
 negotiated seed is \$500 employee only and \$1,000 for all other coverage levels and the
 negotiated match is \$1 for \$1 up to \$300 Employee only / \$600 all other coverage levels.
- If enrolled in Tricare, Medicare Part A or B, you are prohibited to contribute to the enhanced, you must select Standard option.

Covid - 19 Information: Can be obtained on-line using the EB homeport. Upper right-hand corner is a RED square, just select. This provides all updated information concerning COVID-19. Bulletins, Resources, Medical Service Information, EB Case Reports, Personal Safety and Wellness, Facility and Transportation Changes, Travel Guidance, Work from Home Resource, Employee Benefits, Common Terminology, Travel and Public Health Resources and Email Alerts.

The CDC recommending:

- Everyone 18 years and older should get the booster shot.
- Your eligible 6 months after completing your primary Covid 19 vaccination series, with Pfizer or Moderna.
- Your eligible 2 months after completing the Johnson & Johnson primary Covid-19 vaccination.
- Which one should you get? Anyone of the vaccinations authorized in the United States.
- What to expect after scheduling your appointment, bring your CDC covid vaccination record card to your booster shot appointment. You may have side affects, this is normal, it means your body is building protection against Covid-19. Using V-Safe you can let the CDC know of any side affects you may have experienced.

Contract Highlights effective for 2022:

- New Medical Plan-ABHP Select:
 - New for 2022-ABHP Select, Higher deductible and lower premiums.
 - o Deductible: \$2,700/\$5,400 vs. \$1,500/\$3,000 from standard/enhanced.
 - o Co-pay: 80%-20% vs 85%-15% from standard/enhanced.
 - o OOP Max: \$4,100/\$8,150 vs. \$3,000/\$6,000 from standard/enhanced.
 - o Seed to HSA: Not eligible vs. \$500 Single & \$1,000 all other levels.
 - o Match to HSA: Not eligible vs. \$300 Single & \$600 all other levels.
 - Contributions Single \$5, EE/Child \$9, EE/Spouse \$9 and Family \$12.
- ABHP Standard & Enhanced:
 - o Non plan design changes from last year.
 - Weekly Premiums Standard plan: Single \$14, EE/Child \$28, EE/Spouse \$28 and Family \$40.
 - Weekly Premiums Enhanced plan: Single \$17, EE/Child \$34, EE/Spouse \$34 and Family \$46.
- New ABA/Applied behavior Analysis Therapy for Autism services will be covered.
- Dental Enhancements:
 - o Increase annual max from \$2,500 to \$3,000.
 - Fee schedule improvement of 5%.
 - o Increase orthodontic from \$3,250 to \$3,500.
 - Added 4th cleaning for periodontal disease.
 - Weekly premiums Single \$11, EE/Child \$18, EE/Spouse \$19 and Family \$23.
- Company Paid Life Insurance & AD&D Insurance enhancement from 10K to 50K.
- New Optional Life Insurance enhancement from 2 x base pay to 1 to 8 x base pay to \$4M.
- New Optional AD&D coverage: 1 to 10 x base pay to \$2M, cost \$0.023/\$1K per month.

A motion was made (via e-mail) to the E-Council prior to this meeting for the rental of a van to be used to collect and return Cornhole boards and other materials used at the Veteran's Committee Corn Hole Tournament Fundraiser and a vote in favor of 36-3 to accept.

The Veteran's Committee held their 1st Cornhole Tournament to benefit local Veteran Organizations and Armed Forces and their families in our community. The event was held at Foxwoods Casino Celebrity Ballroom on Sunday, November 21, 2021 and was a huge success, with 103 team that participated raising over \$9,600. A motion was made not to exceed \$15,000 to have the Union Hall's carpet removed and replaced, office furniture moved out of the area for work to be performed and sealant of cement slab crack (Glen Pothier), seconded (Aaron Pearson) and passed to accept.
