

December 6, 2018

President William E. Louis called the meeting to order.

<u>President William E. Louis</u> introduced our Local 571 Chaplain, William Hopkins. William lead us in The Pledge of Allegiance then asked to observe a moment of silence for recently deceased retirees Robert Bronson and Derek Deyerle and all deceased union members, family members and to our Veterans past and present, followed by poem and prayer.

<u>President William E. Louis</u> asked for a motion to accept the November 5, 2018 E-Council Meeting Minutes as circulated and posted. A motion was made (Vinny Blanco) seconded (Jim Newman) and passed to accept.

To President William E. Louis from the United Labor Agency thanking us for our recent donation of \$500.00 towards the 2018 ULA Annual Toy Drive.

Officer Reports:

First Vice President Ken Rowland reported that grievance U-0028-18 (members denied 4-10-hour day workweek) was settled, with members being allowed to work the alternative work week schedule. Thanks to Jeremy Deschamps, Joe Huffman and Paul Smith for their work on this grievance. A second Step 3 meeting was held for U-0013-17. The union presented ample evidence that MDA Admin Aide work was performed by salary employees in VA program office. No settlement has been reached as of yet. A member received a 3-day suspension for low work output.

A member was terminated for violation of rules and regulations (recording conversations).

Second Vice President David Reagan reported 1 new Step 3 Grievance was filed, U-0031-18 Disparate Treatment and Sexual Harassment of bargaining unit members by salary personnel. Myself and President Bill Louis along with Councillor Taylor Herb sat in on parts of the investigation. The company made its determination based on their investigation. The Union does not agree with the outcome therefore we filed the Grievance. We are waiting on a Step 3 meeting with HR.

Grievance Rep. Joe Wessell and Councillors Larry Avery and Nicki Reagan had a Step 2 meeting for Grievance U-0030-18 with the Planning department on Non-Bargaining Personnel performing Bargaining Unit work. We are waiting on a Step 3 meeting with HR this week.

We had a member put out of work pending investigation for Violation of Rules and Regulations. He was returned to work after 13 days by Dr. Hurley finding the member fit for duty. Thank you to Councillor Taylor Herb for your help with this member.

Recording Secretary Martha Fletcher reported no new step 3 Grievances. A member was terminated for not responding to a letter from the company to return to work or supply medical documentation for absence to the Yard Hospital.

A member's supervisor has been consistently recording labor time incorrectly due to approved FMLA time resulting in loss of pay and personal time. A meeting was held with the member, the company and union resulting with an agreement the member and supervisor will do the members time together weekly and have in depth monthly reviews. Thank you to Councillors Wayne Carbone and Steve Karavolis for their help working this issue for our member.

Financial Secretary William May reported no new Step 3 Grievances.

Treasurer Robert Faraci reported no new Step 3 Grievances.

Standing Committee Reports:

Loint Technology Committee First Vice President Ken Rowland reported that the committee met to review supply chain issues faced by procurement groups. The committee also met with planning and piping engineer managers to review issues with new piping processes. Many thanks to JTC members Doug Witt, Tom Clancy and Dave Erardy for their work on the committee throughout the year, and to Mike Molinari for his work as Computer Monitor.

<u>Veteran's Committee Officer Bill May</u> reported that the Veteran's Committee will be collecting Turkey Vouchers from anyone who would care to donate theirs. The Turkeys will then be donated to the Veteran's Center in Norwich, CT.

<u>Ioint Apprenticeship Committee Co-Chair Joe Marmaud</u> reported that 8 members per the 4 disciplines (D452, D453, D456 & D459) have been chosen to be in the Apprenticeship Cohort -3 program. Classes will be starting mid-January.

Community Services Committee Chair Joe Wessell reported that the 2018 Electric Boat Employees' Community Service Association Campaign has ended and was very successful. Thank you for all our members who helped out with the Campaign and those who participated with Days of Caring, such as collecting and sorting food.

Education Committee Chair Kim Deschamps reported that the New Member Class 53 will be held in January, and we will be testing a new workshop style class for slightly over 100 members at once. This will hopefully help reduce the backlog of members while still offering a quality class.

Benefits Committee Jim Newman reported we just completed Annual Enrollment which was from November 13–30, 2018 this year. Members should have gone into the GD website to review benefit selections for calendar year 2019. Remember Protection Plus was not an option for 2019. Our committee assisted many members throughout open enrollment, we provided guidance, answered questions as well as attending EB workshops and enrollment presentations.
