<u>First Vice President Amv Stephenson</u> reported no new Step 3 grievances filed.

Second Vice President Bob Canova reported no new Step 3 grievances filed. We represented a member who was sent to the yard hospital for medical evaluation. They were returned to normal duty. We represented a member whose clearance was revoked by Dept. of Defense; they will remain employed as their department has no clearance work for them.

We represented one member, two (2) separate times, who was creating a disturbance in the work place. They received two (2) counselling's by HR and given no progressive discipline. The same member was put on notice for being out of assigned work area for 3 hours, after investigation no action was taken. We represented a member for mischarging while WFH. The member was suspended pending investigation and subsequently voluntary terminated in lieu of discharge.

We represented a retiree with a workers compensation claim for hearing aids that were not working correctly. The member received an earlier appointment for the hearing aide to be adjusted to work until he could get in to see their audiologist.

Recording Secretary Martha Fletcher reported no new Step 3 grievances filed. A member received a documented counselling for commuting to the plant from WFH without punching out. The member had to have the time adjusted through time keeping and WFH privileges revoked.

Insurance and Benefits Committee Tony Giordano reported:

On-site United Healthcare Coordinators and Care Advocates:

United Healthcare has completed the hiring process to fill the vacancy of our Benefits Coordinator Alicia Kelly. UHC is in the process of training their new employee. When she goes live, we will let you know, her name is Elenor Helme.

The Re-Verification Audit:

The dependent re-verification audit has been completed we had three members who have not completed that process and we started reaching out to them to help guide them or help direct them so they will be able to complete the process. Problems I see that in-sufficient Documents provided and uploaded to verify dependent. They have a list to choose from. Our chairman Ed Nevins was also caught up in this process and had to verify his wife who has been on the plan for over 40 years.

Tax Identification Number Errors:

CHQ (Corporate Headquarters) received an ACA (Affordable Care Act) filing report from the IRS that indicates inconsistencies with personal identification information (name and or Social Security number) on record. Information on record does not match information on record with Social Security. To avoid penalties, the company will be reaching out to those in a letter requesting they make the corrections, deadline is December 12, 2024. We have about 25 members affected.
