MDA-UAW Local 571 Executive Council Meeting Minutes October 9, 2024

October 16, 2024

Officer Reports:

<u>First Vice President Amy Stephenson</u> reported no new Step 3 grievances filed. A member was terminated and 3 members received 3-day suspensions for violating rules and regulations.

Second Vice President Bob Canova reported no new Step 3 grievances. We represented one member who was creating a disturbance in the work place using Skype. They received a verbal counselling. We represented a member for leaving work without permission. The member received a memo for a one-day suspension with no time served. We represented a member who was not coming in on their one day inplant hybrid schedule (due to a family issue). We discussed several options with the company and the member, in the end the member chose to retire. We represented a member with a final written warning for lateness. The member had been given additional counseling for lateness after the finial written warning and was continuing to come in late, multiple times. The company suspended the member pending and after investigation they terminated the member. Two members, were called into HR separately, in the same area were turned in by multiple salaried and hourly employees for loud inappropriate for work place (political, generational, China, school shootings, etc.) conversations. The two members were each given verbal counselling's.

Recording Secretary Martha Fletcher reported no new Step 3 grievances filed.

Financial Secretary Dave Evans reported no new Step 3 grievances filed.

<u>Treasurer Robert Faraci</u> reported U-0013-24 non-bargaining unit personnel to perform MDA work. We are in the process to come up with language to settle step 3.

Filed U-0016-24 the MDA-UAW Local 571 grieves the company for allowing salary persons to perform bargaining unit work. Principle engineer D451 was observed setting up work station with meters (multi meter), crimping tools and control boards.

Had a member receive a finale written warning slip for absenteeism.

Multiple EEO meetings/investigations: Remember what you might not think is offensive, it might be to another individual. When a member comes to you with an issue that you need to handle it professionally, remember they came to you so it is an issue to them.
