

The committee is finalizing the Apprentice Standards for review by the JAC.

UAW Region 9A Summer School James Newman reported the MDA, Local 571 members attended the UAW, Region 9A, Summer School program in New York City, July 25th and 26th. Kim Deschamps and JoAnna McClenathan presented some of the panels based on their experience working to organize strike duty sign-up and organizing strategies in preparation of a potential strike. We were interacting with other locals within Region 9A and our Region 9A leaders, Brandon Mancilla, (Director), Vail Kohnert-Yount, (Assistant), Jose Melara (Servicing Representative), and Shawn Fain, (President of the UAW) attended both days.

We took part in workshops and panel discussions to learn about what is going on in our region and what the future of the labor movement looks like. The broad range of topics covered in the 2 days included strategizing for political power, NAFTA and grievance handling.

UAW President Shawn Fain talked to the group about goals for the international UAW, and mentioned how our Region 9A is a leader in working towards them. Overall, it was a great weekend of learning about worker power and building solidarity through discussions with our regional union siblings.

Community Service Committee Co-Chair James Newman reported:

Thursday July 31st after the UNFI Food Show at the Mohegan Sun, with almost 60 volunteers in 2-1/2 hours we packed up 26,156 pounds of food and nonperishable items to be taken back to the Gemma E Moran United Way Labor Food Center to be distributed to local food pantries and partner agencies. That equals 21,797 meals and is a 55% increase over the same show last year exceeding our goal of 14,000 pounds.

Volunteers Needed Tuesday August 19th! Our next day of caring event is after the C&S Food Show at the Mohegan Sun, Earth Expo Center. We will be packing up nonperishable food items to be taken back to the Gemma E Moran United Way Labor Food Center to be distributed to local food pantries and partner agencies. Registration will begin at 3:45 and we will start after a quick photo at 4:15. We should be done about 6:30. Family members and guests are welcome and we will provide

volunteer certificates to those who need them. We expect to be able to collect 36,000 to 40,000 pounds of food. Children are welcome but must be accompanied by an adult.

EBCSA Campaign 2025

Insurance/Benefits Committee 2 VP Robert Canova reported he and Benefits Committee Ed Nevins, Anthony Giordano and Jim Newman are looking into the company's cancellation of the "Fidelity® Personalized Planning & Advice for your workplace savings account." within Fidelity. This only affects people that pay Fidelity to actually do the investing for you, (Fidelity actually buying and selling stocks for you) "Managing your Account".

If you **did not** receive an email with a confirmation of unenrollment, then this **does not** apply to you. This does not affect you if you manage your own accounts (choose yourself what accounts or stocks you invest in) or you are in "Target Retirement Year Accounts" (example 2035, 2040, etc.).

We have asked EB Benefits manager and director to provide us with more information on the issue as we investigate who is affected, why the decision was made and by who? We also asked what if anything will replace it?

We understand from some members that Fidelity has sent them messages saying "You have been unenrolled from Fidelity® Personalized Planning & Advice for your workplace savings account..." "...You can also visit NetBenefits.com or call us at 866-811-6041 to enroll again if you wish.". Fidelity is offering to separately continue to provide "Account Management." for people that request it. We are not sure exactly what that entails or costs.

We will keep you updated as we investigate and receive information.
