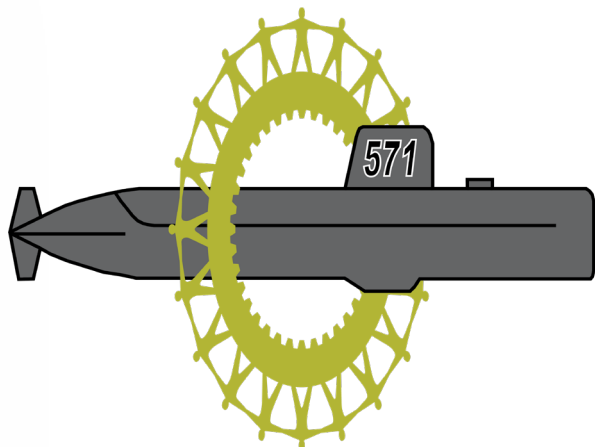

MDA-UAW LOCAL 571 SOUNDINGS NEWSLETTER HISTORY PAGE

The MDA Soundings Newsletter was initially published in the Fall of 1952. For over 71 years it has taken on many shapes and formats, but one thing remains; it continues to inform its members of important new's topics regarding the union and its members.

Attached are a couple news articles published in Soundings Newsletter Volume 1; No. 5; March 1953. The articles deal with topics including adequate area housing and parking snarls.

As you can see, somethings never change at the "Boat"!

PARKING LOT SNAFUS STIR BID FOR ACTION

Widespread dissatisfaction with both morning and evening snarls in the company's parking lots culminated in a concerted bid for action by MDA members late last month.

Approximately half of the union's nearly 600 members signed a petition addressed to Ray Starbuck, MDA head, asking him to call a special meeting so that members can discuss the problem with EB representatives.

Starbuck said last week that because of the press of both personal and MDA business he had had no real chance to talk about the matter with other union officers and that as his resignation is imminent he would have to turn the petition over to incoming president, H. H. Bradford.

Tentative plans now call for development of a program by an MDA member whereby the kinks can be eliminated from the parking lots. This program, it is understood, would be presented to company representatives whenever a meeting date with them can be arranged.

Although details of the proposed parking program were not available at SOUNDINGS' press time, it was reported that a key element in the program calls for some sort of system in which every car operator will be assigned a particular space for his car each day.

Adequate Supply of Apartments Reported in Area; Houses Scarce

Housing for EB employees is a continuing problem but one which personnel department workers feel they have under control.

Both supply and demand vary for particular kinds of housing, they point out, but generally speaking they claim a good record for securing the kind of quarters a majority of EB employees seek.

Personnel department housing files contain a comprehensive list of available houses and apartments within a 30-mile radius of the plant but the emphasis apparently is on the greater New London-Groton area. Many new employees, though, especially those who come here from cities, are anxious to get farm or rural property.

By far the heaviest demand is for three and four-room unfurnished apartments. These, personnel reports, are in the biggest supply. Rents for such abodes run from \$25 (wow!!) to \$100 a month for three-roomers and from the same minimum to about \$125 for four-room arrangements.

The housing staff says it has been able to place about 90 per cent of those seeking three and four-room units.

A Dim View Of Kids

Children aren't welcome, though, in approximately 75 per cent of the available rentals, either apartments or houses.

Most apartments, furnished or unfurnished, come with utilities included in the rent, i.e. heat, water and electricity, although there are exceptions to this general rule.

In short supply, at least in this area, are unfurnished houses to rent. The average tab for these when available, is \$80 a month without utilities. The personnel department reports a very heavy demand for rentals in this category, especially by families with children.

Rents Run High

Nor is there much of a supply of furnished houses to rent. When they are to be had, rents run up to \$150 a month which puts them out of reach of many EB employees.

In the sales field, personnel reports, there are plenty of houses on the market in the \$13 to \$18-thousand bracket. Most banks in the area will underwrite about \$10,000 via the mortgage route on a \$15,000 house although the higher the sales price the greater the percentage of the total the buyer will have to supply as a down payment.

Banks are reported to be reluctant to touch a house that is more than 25 years old unless it is in tip-top shape.

Many EB employees are reported to be buying new houses in the developments which have sprung up throughout southeastern Connecticut in the past few years.

Competition Rugged

Personnel says it is doing all it can in the unfurnished house field, but apparently the competition from non-EB people for the same kind of housing makes the problem difficult.

They cite the case of the EB man from Pitts-burgh with five kids who gave them a month's notice about his housing needs. It took personnel department staffers exactly 27 days to come up with something he could use.

There have been a few reports of rent gouging, but the attitude of the personnel staff is that there is a minimum of that sort of hanky-panky around here.

"We have found property owners in the New London-Groton area are very co-operative so far as EB goes," the housing expert said, "and many of them will hold apartments and houses for our needs without advertising in the local press.

"We, for the most part, try to get from landlords an accurate inventory of conditions in their rentals and we try to examine every dwelling we possibly can so that we can tell employees here exactly what to expect at a given location. Most of them seem to be satisfied," he continued.

Leases Frowned On

There are apparently few rentals in the area where a lease is required and the personnel department people recommend that EB workers sign no lease.

Some people have left EB jobs claiming that they were dissatisfied with housing conditions here but there is reason to believe that in most such cases there were other factors involved.

Dwellings for EB people are spread all over the lot.

A rundown shows that 25 per cent of us live in New London, 16½ per cent in Groton, 4 per cent in Waterford, 8½ per cent in the greater Norwich area, less than 3 per cent west of Waterford and the remaining 37-plus per cent scattered farther afield in Connecticut and Rhode Island.

The Gripe Column . . .

I wish some one would tell me why it is there are only three public phones available for design department employees. In recent weeks I have had occasion to make several emergency calls while at work and invariably have lost valuable time waiting for a booth to be free or padding around the two buildings in the hope that I'd catch a vacant one.

It's apparent to me that a number of people who use the booths now are being hoggish about it and using up time making small-talk with gal friends or boy friends while those of us who really need a phone are forced to stand around shifting from one foot to the other and jingling our coins.

EB, it seems to me, should show some horse sense and have the phone company put in at least three more booths. Lost time for emergency calls would be reduced nearly to a minimum, probably. While they're at it, maybe the company ought to give free lessons, too, in telephone manners.

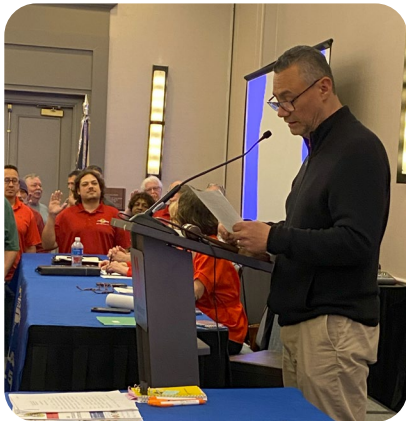


SPECIAL MEMBERSHIP MEETING


